

THREE RIVERS LOCAL SCHOOL DISTRICT BOARD OF EDUCATION REGULAR MEETING JANUARY 26, 2016

The Board of Education of the Three Rivers Local School District met for Regular Session at the Board of Education Offices, 401 North Miami Avenue, Cleves, OH 45002.

The meeting was called to order by the President, Ms. Danette Wells at 5:30 p.m.

Committee Reports

A. Community Forum – Ms. Stafford reported 15 people (5 board/staff and 10 community members) attended the first community forum held on January 21, 2016. Topics discussed included: All Day Kindergarten, Elementary Principal search, use of athletic facilities by community groups, and communications.

Presentations

- **A.** Board of Education Recognition Mr. Hockenberry presented the members of the board with certificates and thanked them for their work.
- **B.** All Day Kindergarten Mr. Hockenberry reported data and costs for all day kindergarten. He shared the enrollment highs, lows, and averages over 20 years. He reviewed costs for additional staff, buses, and materials. He stressed that this is an investment in our children and it comes with a cost. ORC allows parents to only send their kindergartener for half day. The district would allow half day students to leave after morning classwork.
- **C.** Revised Board Policies Mr. Hockenberry shared several policy changes received from OSBA Policy service. Most of the changes concerned student transportation. Mr. Shuey asked that changes be highlighted in the future.
